TRC'S HORSE N AROUND SUMMER CAMP

Topeka Round-Up Club's Horse N Around Summer Camp is an intensive five-day western riding **program** with special guests and outdoor adventures! For over 20 years, our summer camp has given children from different backgrounds a glimpse into the equine world and for many, ignited a passion for horses. Children ages 8-14 can sign up for camp with zero horse experience and by the end of the week, they will know more about horses than you can imagine! Campers will earn **hands-on horse experience** and build an extensive equine education. Many important lessons are taught in a short time frame and more experienced campers get to expand on what they already know. Topics include: how to safely be around horses; how to groom and tack up a horse; basic horsemanship; riding etiquette; horse terminology; identifying colors and markings; breed facts; anatomy; and much more! TRC's facilities include indoor and outdoor arenas so campers will **ride every** day, rain or shine! Campers are assigned a horse and a partner for the week. They will work with their partner to care for their horse and take turns riding. While one partner is riding, the other will be learning in a classroom setting and be provided a snack. Once riding is done for the day and all horses have been cared for, campers will eat lunch (usually around 1:00 PM). TRC's air-conditioned clubhouse provides campers with a nice place to cool down on hot summer days. We offer full-day (7:30 AM - 5:30 PM) and part-day (8:00 AM -2:00 PM) options. All riding will be completed in the morning. Afternoons are filled with fun and exciting horserelated educational activities. Some camper favorites include human horse shows, scavenger hunts, horsethemed games, crafts, and field trips!

DON'T WAIT! SIGN UP TODAY! Camps fill up fast and you don't want to miss out!

ITEMS REQUIRED DAILY:

- O Jeans or long pants (with a belt if possible)
 - Campers will not be allowed to ride without them.
- O Boots with short heels
 - No high-heeled or designer boots (lots of walking and sometimes in dirt/mud)
 - You can find boots at local department stores such as Vanderbilts, Boot Barn, and R Bar B.
- O Helmet
 - Campers are required to wear a helmet while riding and at other times when their hands need to be free.
 - We provide helmets, but some campers prefer to bring their own.
- O Lunch
 - We provide morning and afternoon snacks and water throughout the day.
 - Campers may bring their own water bottles but they must be responsible for them.
- O Sunscreen
 - There will be lots of outdoor time, and we don't want anyone getting sunburned!
- O A change of clothes and/or shoes for afternoon activities (optional)

Parents/guardians are responsible for transportation to and from **Topeka Round-Up Club** (7843 SW 37th Street, Topeka, KS 66614). **Campers must be dropped off no later than 8:15 AM. YOUR CHILD MUST BE SIGNED IN AT DROP-OFF AND SIGNED OUT AT PICK-UP.**

Friday, we will host a **horse show** where campers will have the opportunity to showcase their newly acquired horsemanship skills to family and friends. Campers are split into two different riding groups and will be showing for one hour at **9:30 AM OR 10:30 AM**. If your camper needs a particular time, please let us know at drop-off on Monday so we can assign the correct groups.
